

SUBMISSION AGREEMENT

This Agreement is made between Author and Nau, Inc., a Delaware corporation (“Publisher”) for a story, photograph, cartoon, video and/or other submission (the “Contribution”) which may be published on Publisher’s website.

GRANT OF RIGHTS. For valuable consideration, Author grants to Publisher the non-exclusive right to (1) publish, use, reproduce, distribute, modify, prepare derivative works from, perform, display, and create compilation works from all or parts of the Contribution in any medium or format now known or hereafter invented; (2) use Author’s name (unless anonymous), biographical data, and personal information contained in the Contribution (“Publicity Rights”) to fulfill this Agreement, or for the advertising, promotion, and marketing of Publisher’s website; (3) without limiting the foregoing, exercise all rights stated in Section 3 of Creative Commons Attribution-NonCommercial-NoDerivs License 3.0, and (4) sublicense the Contribution under Creative Commons Attribution-NonCommercial-NoDerivs License 3.0 or (at Publisher’s discretion) any later version thereof.

RESERVATION OF RIGHTS. Author reserves and retains the copyright in the Contribution, including the right to register the copyright and to publish the Contribution elsewhere.

WAIVER OF RIGHTS. Author hereby waives the right to inspect or approve any work of Publisher using the Contribution or the Publicity Rights. Author understands and agrees that the Publicity Rights and Contribution may be used without any restriction, may be modified, may be used in derivative works, included in composites, used in unexpected contexts, or may not be used at all. No breach of this Agreement shall entitle Author to terminate or rescind the rights granted to Publisher herein. Author hereby waives all moral rights and rights of attribution or integrity in or to the Contribution and covenants not to bring any claim or action against Publisher based on a theory of violation of moral rights, or rights of attribution or integrity.

BYLINE. Author agrees to submit his/her real name and address to Publisher before the Contribution is published on Publisher’s website.

REVISIONS. Publisher may revise or edit the Contribution as it sees fit. Under no circumstances will Publisher be liable for any claims of libel, slander, or defamation.

WARRANTY. Author represents and warrants to Publisher that the Contribution (1) has not previously been published; (2) is an original work and a true story; (3) does not infringe, dilute, or violate any statutory rights, common law rights, proprietary rights, or any other right, including but not limited to, copyright, trademark, moral rights, trade secrets, and rights of privacy and publicity; (4) does not defame or libel any person or entity. Author further warrant she/she has obtained all reasonably necessary permissions from all people mentioned in the Contribution.

INDEMNITY. Author agrees to defend, indemnify and hold harmless Publisher for any claim, loss, damage, liability, and expense, including reasonable attorney's fees and costs arising from any actual or alleged breach of any of the foregoing warranties.

INDEPENDENT CONTRACTOR. In performing this Agreement, Author shall act at all times as an independent contractor. Nothing contained herein shall be construed or implied to create a joint venture, agency, partnership, or employment relationship between Author and Publisher.

ENTIRE AGREEMENT. This Agreement, the e-mail with which this Agreement is transmitted, and terms posted at <https://www.nau.com/thecollective/index.jsp> constitute the entire understanding of the parties in relation to the subject matter hereof.

GOVERNING LAW. The laws of the State of Oregon will govern this Agreement. The parties submit to the jurisdiction of the appropriate court in the State of Oregon, USA.

The undersigned states, represents and warrants as follows: I am over 18 years old or I am the parent or legal guardian of the Author. I have the full right, power, and authority to entire into this Agreement without violating any contract, commitment or law that applies to me. I have read and understand the nature and effect of this agreement, and I hereby approve it.
